
TIPS ON KEEPING TRACK OF ALL THIS STUFF

A journal is a useful way to record the important steps that have been taken in pursuing funding for adaptive equipment, home modifications or vehicle modifications. The funding process is typically a time-consuming and often daunting task. One way to make the process efficient is a tracking journal that logs what steps have been taken and what steps need to be completed. Below is a sample of info to include on your tracking form.

- 1. Identify Need.
- 2. List possible solutions.
- 3. List people/organizations to contact for
- 4. Note who was contacted, date and response given.
- 5. List what documentation needed to be obtained for eligibility, for whom & from whom.
- 6. Note dates information requested, mailed, received....
- 7. Keep copies of everything for your records. A file folder & notebook is very useful. Info you have on record can often be used for future needs & solutions.

WHEN ALL ELSE FAILS... APPEAL, APPEAL!!!

- Do they have an appeal process?
- What is the appeal process?
- How much time do you have to appeal?
- Do you have to send the request to appeal in writing?
- What if you cannot make the appeal hearing?
- Did you get a denial letter or a request for more information?
- What did the denial letter say?
- What documents or information do you have to bring to the appeal?
- Should you bring an advocate to the appeal?
- Is there an appeal after the appeal?
- How many appeals can you make and to who/where?

Accessible Housing

Mass Access: The Accessible Housing Registry

helps people find affordable housing in Massachusetts. A key feature of the registry is to highlight homes for people with disabilities who need accessible or barrier-free housing. Massachusetts law states they must list available housing for thirty days before listed to public. Massachusetts Rehabilitation Commission Adaptive Housing Program MRC's Adaptive Housing Program's goal is to provide accessible housing to individuals with disabilities in their primary, permanent residence to enhance their ability to participate in vocational services, and to return to work. The Adaptive Housing Program provides architectural modifications to the private residences of individuals and related equipment installation to remove impairment related barriers to occupancy by the individual. Examples of modifications that may be eligible under this program are wheelchair access via lifts, ramps, door widening, or bathroom modifications such as roll in showers

Any individual who has a physical or mental impairment which constitutes or results in a substantial impediment to employment. The individual must require vocational rehabilitation services to prepare for, enter, engage in or retain work and the individual can benefit from vocational rehabilitation services in terms of an employment outcome. The maximum dollar limit about is \$15,000. However the Commission may approve expenditure of more than \$15,000 limit for adaptive housing services when exceptional circumstances warrant a waiver. Financial participation is based on annual income and cash assets. 780 CMR: STATE BOARD OF BUILDING REGULATIONS AND STANDARDS IN THE MASSACHUSETTS STATE BUILDING CODE

780 CMR 3603.15 RAMPS

3603.15.1 Maximum slope: All egress ramps shall have a maximum slope of one unit vertical in eight horizontal (12.5% slope).

Exception 1: The maximum slope of ramps for person with disabilities shall be one unit vertical in twelve units horizontal.

Exception 2: Where access for person with disabilities is legally mandated, ramps shall be constructed in accordance with the requirements of 521 CMR as listed in *Appendix A*.

3603.15.2 Guardrails and handrails: Guardrails shall be provided on both sides of all ramps and shall 3603.14.2. Handrails conforming to 780 CMR 3603.14.1 shall be provided on at least one side of all ramps exceeding a slope of one unit vertical in 12 units horizontal (8% slope).


Exception 1: For person with disabilities handrails shall be provided on both sides of the ramp when the vertical rise between landings exceeds six inches.

Exception 2: Where access for persons with disabilities is required by stature, ordinance or bylaw, guardrails and handrails shall be provided in accordance with the requirements of 521 CMR as listed in *Appendix A*.

3603.15.3 Landing Required: A minimum three-foot-by-three-foot (914mm by 914 mm) level landing shall be provided at the top and bottom of ramps where doors open onto the ramp and where ramp changes direction.

Exception 1: Ramps required for persons with disabilities shall not have a vertical rise greater than 30 inches between landings.

Exception 2: Where access for persons for persons with disabilities is legally mandated, landing requirements shall conform to the requirements of 521 CMR as listed in *Appendix A*.
